

GOEIC VERIFICATION OF CONFORMITY (VOC) PROGRAMME

The General Organization of Export and Imports Control (GOEIC), under the Egyptian Ministry of Industry and Trade, regulates the certification requirements for imported goods as per 770/2005, 961/2012, 991/2015, 43/2016, 44/2019, 96/2022.

This guide covers the requirements of obtaining the mandatory Certificate of Conformity (COC), required for customs clearance.

The Certificate of Conformity is issued by GOIEC Registered Inspection Companies like Cotecna Inspection S.A (Cotecna) and is needed for every consignment of regulated goods.

Attention: For exporters shipping food and food contact products, please refer to the NFSA certification guide.

Please note, some products are subject to certification under both GOEIC and NFSA programmes.

GOEIC Exempted Products

- > Wallets Belts
- > Bags in textile
- > Wristlets (meaning bracelets)

Important: If wallets and belts are included in the same shipment as regulated products, then they are subject to conformity assessment, testing and reporting on the COC. However, if wallets and belts are shipped separately, no COC needs to be issued for them.

3. GOEIC CERTIFICATE OF CONFORMITY PROCESS

To issue a shipment Certificate of Conformity, Cotecna follows the following process:

1. Documentation verification

The exporter/applicant must provide Cotecna with the following documents for verification:

- i) A filled out Cotecna Request for Certification form
- ii) Commercial Invoice: Please note, it is a GOEIC requirement to declare the manufacturer's name and address in addition to the importer and exporters' full contact details.
- iii) Trademark licenses
- iv) Packing List
- v) Transport document, for instance, bill of larding (B/L) or airway bill (AWB) to be submitted after inspection
- vi) Valid conformity documents* (such as laboratory test reports, Quality Management System certificate- Oeko-Tex certificate, Bluesign certificate, IEC certificate, etc) and any other relevant documentation.
- * A conformity document is valid when:
- > It has been issued by an ISO 17025 accredited laboratory. The scope of lab accreditation must be relevant to the required tests.
- > If traceability between the conformity document and the goods of the consignment can be established.
- > It covers the exact same production batch as the goods exported.
- > It strictly covers 100% of the products in the consignment.
- > It is in compliance with Egyptian standards and requirements.

2. Laboratory testing in the exporting country

If the product test report is not available or is missing essential test criteria, Cotecna will take samples from the shipment and perform the necessary tests in an ISO 17025 accredited laboratory.

3. Physical inspection in exporting country

Cotecna will physically inspect the goods and ensure essential markings comply with Egyptian standards, take samples (see above) and seal the container if required.



4. Certificate of Conformity

Cotecna will issue a Certificate of Conformity (COC) only if the exporter/application meets the Egyptian requirements, following a successful completion of the evaluation, inspection and testing.

5. Fees

Costs of the inspection, analysis and/or certification are borne by the seller and are quoted at the time of nomination. Cost varies depending on the products certified and exporting country. This program is subject to the Cotecna General Terms and Conditions.

Obtaining a Quality Certificate

An important additional GOIEC requirement is the mandatory registration of Trade-mark owners and distributors. This specific process requires applicants to present, among other documents, an ISO 9001 certificate or Quality Certificate. Cotecna can help applicants obtain Quality Certificates, following a successful review and audit of the applicants' quality management system.

To request a Quality Certificate, applicants are requested to submit Quality Management Control procedures and/or manuals including supply chain control procedures. Following a document review, Cotecna will perform a factory audit and issue the Quality Certificate upon satisfactory results.
